Guarantee & Adherence Agreement dated 8 July 2021 (the "Guarantee and Adherence Agreement")



1. We refer to the Guarantee and Adherence Agreement. This is an Accession Letter. Terms defined in the Guarantee and Adherence Agreement have the same meaning in this Accession Letter unless given a different meaning in this Accession Letter.
2. CARBETO DE SILÍCIO SIKA BRASIL LTDA. agrees to become a Guarantor and to be bound by the terms of the Guarantee and Adherence Agreement pursuant to Clause **Erro! Fonte de referência não encontrada.** (*Acceding Guarantor*) of the Guarantee and Adherence Agreement. CARBETO DE SILÍCIO SIKA BRASIL LTDA. is a company duly incorporated under the laws of Brazil and is a limited liability company, with registration number CNPJ 32.870.697/0001-48.
3. CARBETO DE SILÍCIO SIKA BRASIL LTDA., as Guarantor, hereby expressly waives the benefit of order (*benefício de ordem*) and any and all entitlements of any nature stemming from Articles 333, sole paragraph, 366, 368, 827, 834, 835, 837, 838 and 839 of Law No. 10,406, of January 10 2002 ("Brazilian Civil Code") and of Articles 130 and 794 of Law No. 13,105, of 16 March 2015 ("Brazilian Code of Civil Procedure"). The Guarantor also recognizes that the Guarantee and Adherence Agreement shall not be considered as a limited instrument of guarantee for the purposes of Article 822 of the Brazilian Civil Code.

5. Brazilian Formalities. Notwithstanding the provisions of the Guarantee and Adherence Agreement, the undersigned Guarantor agrees to perform, or cause to be performed, as soon as possible from the date hereof (with respect to this Accession Letter) and as soon as practically possible from a request from the Security Agent in respect of any amendments or documents relating to the Guarantee and Adherence Agreement, the following acts:

- a. the notarization of the signatures of the parties who have signed this Accession Letter outside Brazil by a notary public licensed as such under the law of the place of signing and, as applicable, apostilled (in Hague Convention countries) or authenticated by the Brazilian Consulate nearest to the place of execution;



- b. the translation of the relevant document into Portuguese by a certified translator (*tradutor público juramentado*); and
 - c. the registration of the relevant document together with its respective certified Portuguese translation, with the appropriate Registry of Deeds and Documents (*Cartório de Registro de Títulos e Documentos*).
6. The Guarantor hereby submits to the exclusive jurisdiction of the City Court of Stockholm (Sw. Stockholms tingsrätt) to settle any Dispute, provided, however, that the Secured Parties shall have the right to take proceedings relating to a Dispute in any other courts with jurisdiction (including Brazilian courts). The Guarantor hereby appoints and constitutes, irrevocably and irreversibly, Fiven ASA as its attorney in-fact upon whom process may be served in any suit or proceeding arising out of or relating to this Accession Letter, the Guarantee and Adherence Agreement or the transactions contemplated thereby. Service of process upon Fiven ASA shall be deemed, in every respect, effective service of process upon any of the undersigned Guarantor.
7. This Accession Letter is governed by Swedish law.


